

2022 Water usage update Utilities Department

Blue Ridge/N. Salford: Phase I of the Water/Wastewater Expansion Construction scheduled to begin in late 2023

In May, 2023, North Port Utilities held a Water & Wastewater Expansion Workshop at the Morgan Family Community Center to provide information to area residents regarding Phase 1 of the Blue Ridge/N. Salford plan. Phase 1 of the project is set to break ground in the fall of 2023. Property has been purchased for the vacuum station which is the first step in the construction process.

North Port Utilities has put the design out for bid to contractors who will be able to construct the project as outlined. Once bids are received, they will be presented to Commission for approval. Community meetings will be held during 2023 within the Phase I neighborhood to provide information regarding the design, cost and project timeline.

Currently, existing homeowners within the Blue Ridge/N. Salford area will be offered an early incentive to connect to the system as construction occurs within their neighborhood. City of North Port Commissioners have approved a maximum amount for existing homeowners who participate in the program.

Cost to existing homeowners: \$2,255 for wastewater and \$5,654 for water and wastewater service.*

Commission also approved a 30-year payment plan and a hardship program. After construction is complete and the participation period for the early incentive program has passed, homeowners would be required to pay the full amount of the construction cost and capacity fees. Based on similar projects in neighboring communities, the estimated total construction cost without incentives, grants and matching funding could be up to \$35,000.

The City of North Port will have numerous informative seminars and community meetings as the project progresses. There will also be commission meetings throughout the process of development, approval and construction. Our rates are designed to encourage conservation. Therefore, the more water you use, the more you are charged per 1,000 gallons of water used. The first 4,000 gallons are billed under the first tier; the second 4,000 gallons are billed under the second higher tier and so on.

Reclaimed water (non-potable) is \$.55 per thousand and \$.21 per thousand for bulk users.

Meters are read monthly by utility staff and customers are billed monthly.

Average consumption

The state average daily consumption is 103 gallons per person, which comes to over 6,100 gallons per month for a household of two.
