LICENSE & USAGE

- **B.** No Agency: Nothing contained herein or having to do with this sponsorship shall be deemed or construed as creating the relationship of principal and agent, or of partnership or joint venture, between the City and the Sponsor. The parties understand and agree that no provision contained herein, and no acts of the parties shall be deemed to create any relationship between them other than that as detailed within City Resolution No. 2019-R-05. - C. Non-Discrimination: The City of North Port, Florida, does not discriminate on the basis of race, color, national origin, sex, age, disability, family, or religious status in administration of its programs, activities, or services. - D.
