

# City of North Port

## **ORDINANCE NO. 2020-11**

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE ROAD AND DRAINAGE DISTRICT BUDGET FOR FISCAL YEAR 2019-20 BY PROVIDING FOR CHANGES IDENTIFIED IN EXHIBIT A TO TRANSFER \$1,042,710 FROM FUND BALANCE TO THE ROAD MAINTENANCE PROGRAM; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Road and Drainage District is a dependent special district; and

WHEREAS, the City Commission of the City of North Port, Florida, serves as the governing body of the district (the "Board"); and

WHEREAS, the Board has all the powers granted by the City Charter and the general laws of the state as may be necessary or proper to carry out the intent and purpose of the district; and

WHEREAS, Ordinance No. 2019-43 approved the Road and Drainage District Budget for fiscal year 2019-20; and

WHEREAS, the Board desires to amend the Road and Drainage Budget for supplemental appropriations in the amounts identified in Exhibit A: and

WHEREAS, Section 166.241(4)(c) Florida Statutes require such a budget amendment be adopted in the same manner as the original budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE ROAD AND DRAINAGE DISTRICT:

## **SECTION 1 – FINDINGS**

1.01 The recitals outlined above are incorporated by reference as findings of fact as if expressly set forth herein.

## **SECTION 2 - ADOPTION**

2.01 The Road and Drainage District Budget for fiscal year 2019-20 is hereby amended by providing for changes identified in Exhibit A, attached hereto and incorporated by reference as if set forth herein.

#### **SECTION 3 – CONFLICTS**

3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance or portions thereof, the provisions of this ordinance shall prevail to the extent of such conflict.

#### **SECTION 4 – SEVERABILITY**

4.01 If any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

## **SECTION 5 - EFFECTIVE DATE**

**CITY ATTORNEY** 

5.01 This ordinance shall take effect immediately upon adoption.
