### ORDINANCE NO. 2020-20

**AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET FOR FISCAL YEAR 2019-20 BY TRANSFERRING \$2,860,218 FROM THE PARK IMPACT FEE FUND BALANCE, \$24,842 FROM THE FIRE/RESCUE IMPACT FEE FUND BALANCE, AND \$85,947 FROM LAW ENFORCEMENT IMPACT FEE FUND BALANCE, AND INCREASING THE ESTIMATED REVENUES FOR THE PARK IMPACT FEE FUND FOR REIMBURSEMENT OF COSTS AS OUTLINED IN THE WEST VILLAGES DEVELOPER AGREEMENT (POST ANNEXATION); PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Ordinance No. 2019-41 approved the Non-District Budget for fiscal year 2019-20; and

**WHEREAS**, the City Commission desires to amend the Non-District Budget for supplemental appropriations and to increase estimated revenues; and

**WHEREAS**, Section 166.241(4)(c) Florida Statutes requires that a budget amendment be adopted in the same manner as the original budget.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

#### **SECTION 1 – FINDINGS**

1.01 The recitals outlined above are incorporated by reference as findings of fact as if expressly set forth herein.

#### **SECTION 2 – ADOPTION**

2.01 The Non-District Budget for fiscal year 2019-20 is hereby amended as follows:

**SECTION 5 – EFFECTIVE DATE**

5.01 This ordinance shall take effect immediately upon adoption.
