ORDINANCE NO. 2021-16

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET FOR FISCAL YEAR 2020-21 BY TRANSFERRING \$127,151 FROM THE GENERAL FUND BALANCE FOR NARRAMORE PARK SECURITY, THE FIRST 1000 DAYS MURAL PROJECT, AND THE NORTH PORT SPECIAL ELECTION; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 2020-31 approved the Non-District Budget for fiscal year 2020-21; and

WHEREAS, the City Commission desires to amend the Non-District Budget for supplemental appropriations and to increase estimated revenues; and

WHEREAS, Section 166.241(4)(c) Florida Statutes requires that a budget amendment be adopted in the same manner as the original budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 – FINDINGS

1.01 The recitals outlined above are ratified and approved as true and correct, and are incorporated by reference as findings of fact.

SECTION 2 – ADOPTION

2.01 The Non-District Budget for fiscal year 2020-21 is hereby amended as follows:

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 5 – EFFECTIVE DATE

5.01 This ordinance takes effect immediately upon adoption.
