



# City of North Port

## ORDINANCE NO. 2021-25

**AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE SOLID WASTE DISTRICT BUDGET FOR FISCAL YEAR 2020-21 BY TRANSFERRING \$40,265 FROM FUND BALANCE FOR THE PURCHASE OF LAND FROM THE ROAD AND DRAINAGE DISTRICT FOR THE DEVELOPMENT OF AN ORGANICS TRANSFER STATION; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the North Port Solid Waste District is a dependent special district; and

**WHEREAS**, the City Commission of the City of North Port, Florida, serves as the governing body of the district (the "Board"); and

**WHEREAS**, the Board has all the powers granted by the City Charter and the general laws of the state as may be necessary or proper to carry out the intent and purpose of the district; and

**WHEREAS**, Ordinance No. 2020-34 approved the Solid Waste District Budget for fiscal year 2020-21; and

**WHEREAS**, the City Commission desires to amend the Solid Waste District Budget for supplemental appropriations and to increase estimated revenues; and

**WHEREAS**, Section 166.241(4)(c) Florida Statutes requires that a budget amendment be adopted in the same manner as the original budget.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE SOLID WASTE DISTRICT:**

### **SECTION 1 – FINDINGS**

1.01 The recitals outlined above are ratified and approved as true and correct, and are incorporated by reference as findings of fact.

### **SECTION 2 – ADOPTION**

2.01 The Solid Waste District Budget for fiscal year 2020-21 is hereby amended as follows:

**SECTION 3 – CONFLICTS**

3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

**SECTION 4 – SEVERABILITY**

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

**SECTION 5 – EFFECTIVE DATE**

5.01 This ordinance takes effect immediately upon adoption.
