ORDINANCE NO. 2021-30

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NORTH PORT FIRE RESCUE DISTRICT BUDGET FOR FISCAL YEAR 2020-21 BY INCREASING REVENUES BY \$600,000 FROM CARES ACT PAYMENTS FOR ADDITIONAL FUNDING FOR THE FIRE/POLICE TRAINING TOWER; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the North Port Fire Rescue District is a dependent special district; and

WHEREAS, the City Commission of the City of North Port, Florida, serves as the governing body of the district (the "Board"); and

WHEREAS, the Board has all the powers granted by the City Charter and the general laws of the state as may be necessary or proper to carry out the intent and purpose of the district; and

WHEREAS, Ordinance No. 2020-32 approved the Fire Rescue District Budget for fiscal year 2020-21; and

WHEREAS, the Board desires to amend the Fire Rescue District Budget for supplemental appropriations and to increase estimated revenues; and

WHEREAS, Section 166.241(4)(c) Florida Statutes requires that a budget amendment be adopted in the same manner as the original budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE NORTH PORT FIRE RESCUE DISTRICT:

SECTION 1 - FINDINGS

1.01 The recitals outlined above are ratified and approved as true and correct, and are incorporated by reference as findings of fact.

SECTION 2 – ADOPTION

2.01 The Fire Rescue District Budget for fiscal year 2020-21 is hereby amended as follows:

Additional Budget for Project F15FPT Fire/Police \$600,000
Training Tower

Public Safety Grant Revenue \$600,000

Budget Amendment Total \$600,000 \$600,000

SECTION 3 – CONFLICTS

3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

SECTION 4 – SEVERABILITY

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 5 – EFFECTIVE DATE

5.01 This ordinance takes effect immediately upon adoption.
